Hold Harmless Clause

I, _____, understand that Loving Care Cat Rescue (LCCR) makes no guarantee relating to the animal’s health, behavior or actions. I understand that I receive foster care animals at my own risk.

I agree to hold LCCR free and harmless from all liability arising out of all claims, demands, losses, damages, actions or judgments of any kind and description which may occur to or be suffered by me, members of my household, or any third parties, and to my personal pets by reason of activities arising out of my acceptance of an LCCR foster cat or cats.

Conditions of Release of Animal

If I am unable to continue to foster, I will notify the Executive Director of LCCR Lisa Snyder as soon as possible to allow LCCR to locate another foster home for the cat(s) in my care. To that end I will allow LCCR reasonable time to make alternative arrangements for the foster cat(s) I am relinquishing.

The LCCR foster cat(s) in my care will not be surrendered to a shelter, abandoned, or given away for any reason under any circumstances. In the event of an issue or problem with my foster cat(s), I will promptly notify the Director or a Board Member

If LCCR deems that the foster animal in my custody is not properly cared for in a clean, safe, warm, and pest-free environment, LCCR will require that I relinquish the animal to Loving Care Cat Rescue immediately, along with all medical records and medications in my possession.

Policies and Policy Violation

I will keep LCCR foster cat(s) in my possession at all times and not transfer them to other homes or people unless directed or agreed to by LCCR.

I will not take in any fosters without the approval of an LCCR Board Member.

Authorization for the euthanasia of any foster cat in my care can only be given by the LCCR Executive Director. I understand that I am not permitted to provide this consent.

LCCR reserves the right to end the foster arrangement if any policy of LCCR has been violated, in which case any foster cat(s) in my care must be surrendered back to LCCR with all medications and medical records.

All foster cat(s) are within the legal ownership and protection of LCCR until such time as an Adoption Contract is completed and transfer of the cat(s) from foster care (LCCR) to a permanent home (New Owner) is completed.

I understand that although LCCR will do everything possible to supply medications, food, and litter... I will be required at times to provide food and litter personally financially for the foster cat(s) in my care.

By way of my signature below, or electronic submission of this form, I affirm that I have reviewed, understand, and hereby agree to (1) adhere to the terms and policies listed above (2) adhere to LCCR Foster Caregiver Guidelines and (3) adhere to the standards, processes and regulations set forth by the Loving Care Cat Rescue Board of Directors currently in place or as changed in the future.
